



Introduction

Asia Association of Medical Laboratory Scientists (AAMLS) authorized Korean Association of Medical Technologists (KAMT) to be the member association taking place for the laboratory training course. The purpose of this laboratory educational training program is to strengthen laboratory competence in a resource limited country by inviting a selected member to Korea for clinical laboratory educational training.

1. **Theme:** A short term education and learning program for medical laboratory scientists whose applications meet the criteria of AAMLS.
2. **Final selection for participation:** 2 members.
3. **Application period:** August 15th, 2015 to 28th 2015.
4. **Training period:** 26 – 30, October, 2015 (one week)
5. **Laboratory education and training course duration:** 5 days.
6. **Accommodation and meals:** 7 days/6 nights (cover by KAMT)
7. **Flight ticket round trip:** Economy class (cover by KAMT)
8. **Training place:** Department of Laboratory Medicine, Seoul National University Hospital, Seoul, Korea
9. **Hospital:** Seoul National University Hospital
10. **Certification:** From the president of KAMT and president of AAMLS.

Application and Required Documents:

1. Completed application form (Attachment)
2. Recommendation letter from your academic supervisor or director of laboratory
3. Curriculum Vitae
4. Photocopy of the diploma for Degree in Medical Laboratory Science or Related.
5. Photocopy of valid license in Medical Laboratory Science or Related

6. Photocopy of your passport (the page containing personal information and photograph).
7. Proof of travel insurance (if available).

(In case that any of the diplomas, certificates or licenses are not in English, please submit the English translation certified by the governmental authorities.)

Application Process

Application documents will be reviewed by the Education and Laboratory Twinning Committee of AAMLS, and then be further evaluated by the President of AAMLS. Upon approval, the selected applicants will receive a letter of acceptance, which will be required when obtaining the Korean visa. The application processing time will be around one week.
